

RESOLUTION JT-2025-06

**A RESOLUTION DECLARING A NUISANCE AT 6931 WOOD STREET, CRESTLINE, OH  
44827**

The Board of Township Trustees of Jefferson Township, Crawford County, Ohio, met in regular session on the 23rd day of June, 2025, with the following members present:

Matthew Weber

Roger Perkins

Mr. Walker moved the adoption of the following resolution:

WHEREAS, the Board of Trustees of Jefferson Township has duty to provide for abatement, control, or removal of vegetation, garbage, refuse, and other debris from land in the township;

WHEREAS, Ohio Revised Code Section 505.87 authorizes a township to adopt a resolution, to abate, control, or remove of vegetation, garbage, refuse, and other debris from land in the township;

WHEREAS, Ohio Revised Code Section 505.87 authorizes a township to adopt a resolution, to abate, control, or remove of vegetation, garbage, refuse, and other debris from land in the township;

WHEREAS, Ohio Revised Code Section 505.87 authorizes a Township to request the County Auditor place on the tax duplicate of the property the providing notice, any fees or interest paid to borrow moneys, and the amount paid for labor, materials, and equipment.

**THEREFORE BE IT RESOLVED**, by the Board of Trustees of Jefferson Township, Crawford County, Ohio that:

1. The Board of Trustees hereby, from the effective date of this Resolution, finding it necessary and in the interest of the public health and safety of the citizens of the Township finds that nuisance exists at 6931 Wood Street, Crestline OH 44827 necessitating the abatement, control, or removal of vegetation, garbage, refuse, and other debris from land in the township.
2. The Board of Trustees have made a finding of fact that nuisance exists by hearing testimony of township employees and affected parties, and observing exhibits of overgrown noxious weeds and vegetation.
3. The Board of Trustees have adopted resolution JT-2024-27 on 23 September 2024 to the same effect.
4. The property owner at 6931 Wood Street, Crestline OH 44827 is hereby ordered to abate, control, or remove the vegetation, garbage, refuse, and other debris from the property within four (4) days.
5. The Board authorizes the Zoning Inspector or his designee to notify the record owner and lienholders of the Property as provided in §505.87(B) of the Ohio Revised Code.
6. If the record owner does not remove the vegetation, garbage, refuse, and other debris from the property or make arrangements for the removal within four (4) days from the receipt of notice hereof, the Zoning Inspector or his designee is authorized to order Township employees, materials and equipment to be used to remove the nuisance elements or to enter into a contract with some suitable person or persons for its removal, and all costs and expenses so incurred shall, when approved by the Board, be paid out of the unappropriated monies in the general fund.

7. The Fiscal Officer shall report all expenses that the Township incurs in the removal of the nuisance elements to the County Auditor for entry upon the tax duplicate as a lien upon the property and for collection and reimbursement of the Township's general fund as provided in §505.87 of the Ohio Revised Code.

8. This Board finds and determines that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in open meetings of this Board, and that all deliberations of this Board that resulted in formal actions were taken in meetings open to the public, in compliance with all legal requirements, including but not limited to, Ohio Revised Code Section 121.22, except as otherwise permitted thereby.


