A RESOLUTION DECLARING A NUISANCE AT
2205 STATE ROUTE 602, CRESTLINE, OHIO 44827

The Board of Township Trustees of Jefferson Township, Crawford County, Ohio, met in regular session on the 27th day of October, 2025, with the following members present:

Mr. Matt Weber moved the adoption of the following resolution:

WHEREAS, the Board of Trustees of Jefferson Township, Ohio has a policy to secure or remove nuisance structures found within the said Township;

WHEREAS, the Township has duty to provide for abatement, control, or removal of vegetation, garbage, refuse, and other debris from land in the township;

WHEREAS, Ohio Revised Code Section 505.87 authorizes a township to adopt a resolution, to abate, control, or remove of vegetation, garbage, refuse, and other debris from land in the township;

WHEREAS, Ohio Revised Code Section 505.87 authorizes a township to adopt a resolution, to abate, control, or remove of vegetation, garbage, refuse, and other debris from land in the township;

WHEREAS, Ohio Revised Code Section 505.87 authorizes a Township to request the County Auditor place on the tax duplicate of the property the providing notice, any fees or interest paid to borrow moneys, and the amount paid for labor, materials, and equipment.

THEREFORE BE IT RESOLVED, by the Board of Trustees of Jefferson Township, Crawford County, Ohio that:

1. The Board of Trustees hereby, from the effective date of this Resolution, finding it necessary and in the interest of the public health and safety of the citizens of the Township finds that nuisance exists at 2205 State Route 602, Crestline, Ohio,

necessitating the abatement, control, or removal of vegetation, garbage, refuse, and other debris from land in the township.

2. The Board of Trustees have made a finding of fact that nuisance exists by hearing testimony of village employees and affected parties, and observing exhibits of overgrown vegetation, garbage, refuse, and other debris.
3. The Board of Trustees previously resolved on the 23rd day of June, 2025 finding it necessary and in the interest of the public health and safety of the citizens of the Township finds that nuisance exists at 2205 State Route 602, Crestline, Ohio, necessitating the abatement, control, or removal of vegetation, garbage, refuse, and other debris from land in the township.
4. The property owner at 2205 State Route 602, Crestline, Ohio is hereby ordered to abate, control, or removal of vegetation, garbage, refuse, and other debris from the property within four (4) days.
5. The Fiscal Officer to hereby ordered to:
 - a. Obtain a title search to determine interested party or parties;
 - b. Provide proper notice to interested party or parties;
