**A RESOLUTION OF THE TOWNSHIP OF JEFFERSON, CRAWFORD COUNTY,
OHIO,
AUTHORIZING LEGAL COUNSEL TO INITIATE LITIGATION**

Mr. Walters introduced and moved the adoption of the following Resolution:

BACKGROUND

WHEREAS, the Board of Trustees of Jefferson Township, Crawford County, Ohio (the "Board") is familiar with the property generally located at 1404 North Market Street Road, Galion, Ohio 44833 (Crawford County Parcel No. 26-00-06450-000) (the "Property"); and

WHEREAS, the Property is wholly located in Jefferson Township, Crawford County, Ohio (the "Township"); and

WHEREAS, the individual with an ownership interest in the Property is Amy S. Tomecko, aka Amy Glass, aka Amy Lough (the "Property Owner"); and

WHEREAS, the property is, and has been, in violation of the Jefferson Township Zoning Resolution (the "Code"); and

WHEREAS, Section 519.24 of the Revised Code authorizes the Board to institute injunction, mandamus, abatement, or any other appropriate action or proceeding to prevent, enjoin, abate, or remove zoning violations; and

WHEREAS, Section 519.24 of the Revised Code authorizes the Board to employ special legal counsel to represent it in any proceeding or to prosecute any actions brought under this section; and

WHEREAS, the law firm of Brosius, Johnson & Griggs, LLC (the "Law Firm"), are engaged as the Township's special legal counsel for the year 2026 in accordance with Ohio law and Board Resolution JT-2026-03.

RESOLUTION

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF TOWNSHIP TRUSTEES OF JEFFERSON TOWNSHIP, CRAWFORD COUNTY, OHIO, THAT:

RESOLVED, that the Board authorizes the filing of a complaint in the Crawford County Court of Common Pleas in connection with the zoning violations on the Property and the taking of any and all actions associated therewith.

RESOLVED, that the Board hereby authorizes, empowers, and appoints, on behalf of the Board, Michael Swick, Zoning Inspector, to execute any and all documents necessary or desirable to effectuate the purposes authorized and set forth in this Resolution.

RESOLVED, that the law firm that serves as special counsel for the Board is hereby authorized to take any steps deemed necessary or desirable in order to effectuate the purposes authorized and set forth in this Resolution including, but not limited to, the preparation and filing of a complaint and any and all related documents, and the taking of actions in order to obtain the Property's full compliance with the provisions of the Code.

BE IT FURTHER RESOLVED, it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this resolution were taken in an open meeting of this Board, and that all deliberations of this Board and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

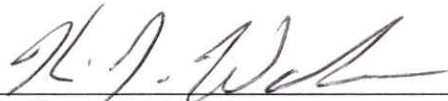
